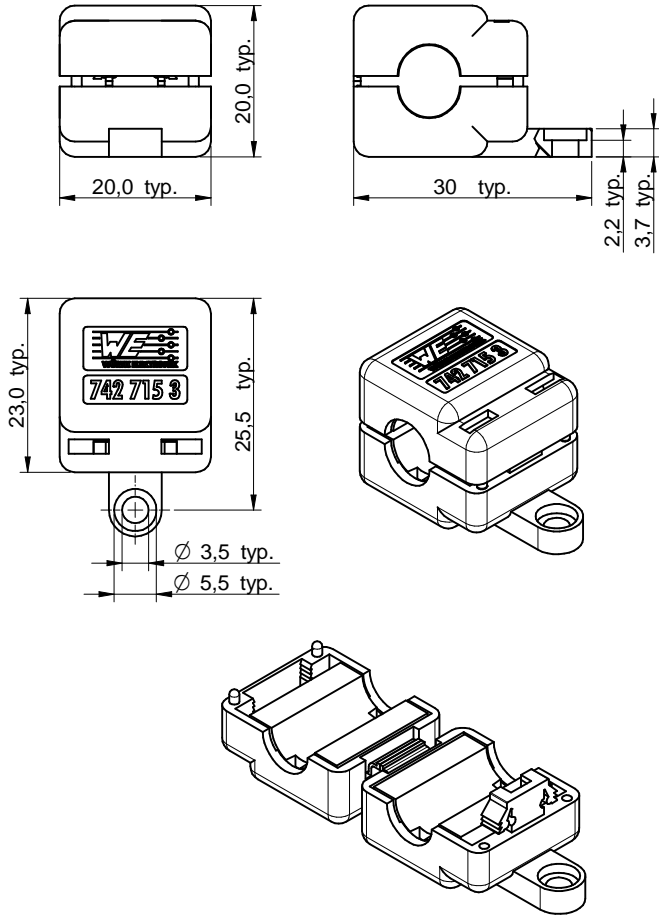
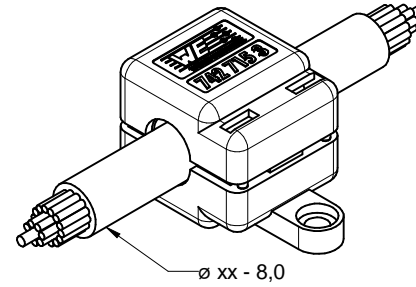

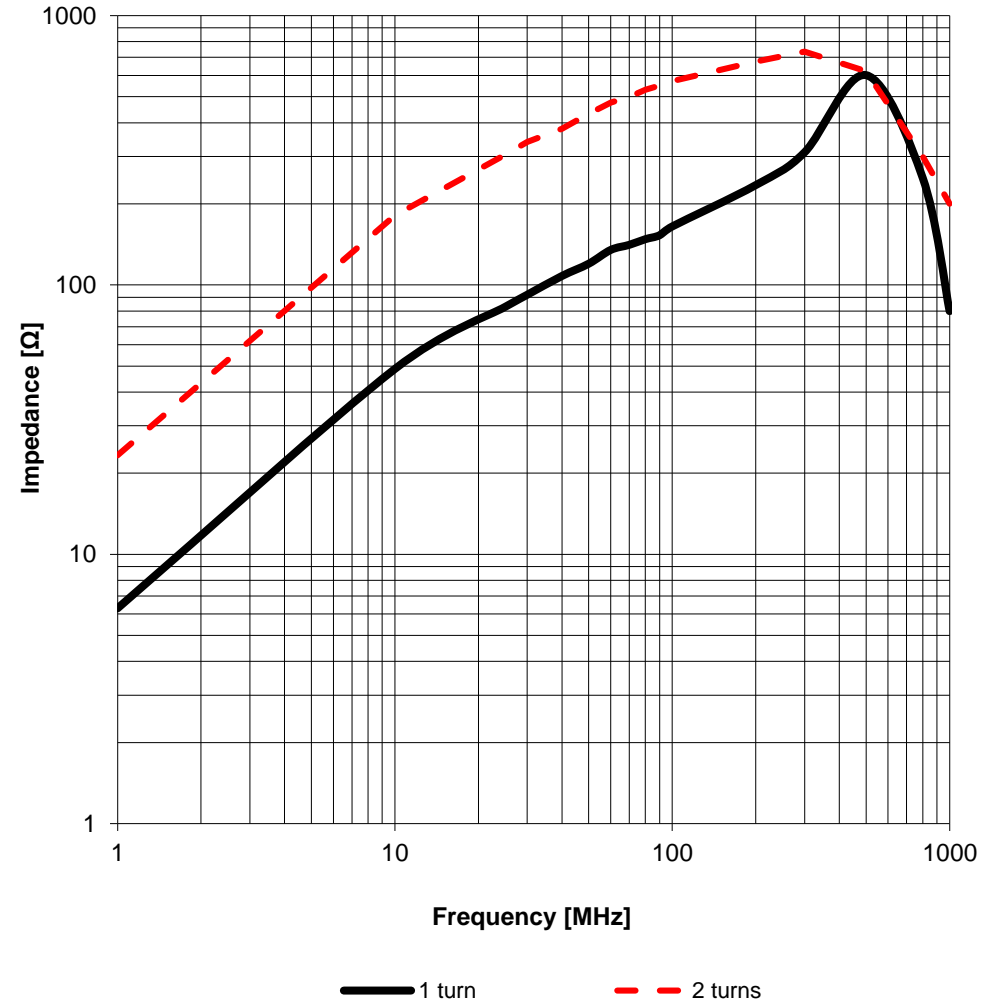

The packaging of the product is to encase the needed humidity of the plastic housing. To ensure the humidity level, the products have to be stored in this delivered packaging. If not, the products are losing their humidity. In this case you can re-condition the components according to the internal standard WE1581 to ensure the necessary humidity in the plastic.

For further information about this internal standard please refer to the document 'WE-Standard 1581' which can be downloaded from the respective product page on our website.

To ensure the operating mode of the product, the ambient temperature at processing (when the part will be mounted on the cable) has to be in the range of 15 to 35 °C. Before mounting, the part should be stored for one hour in this condition. The responsibility for the applicability of customer specific products and the use in a particular customer design is always within the authority of the customer. 
Direct mechanical impact to the product and the forcible closing of this shall be prevented as the ferrite material of the ferrite body or the plastic housing could flake or in the worst case it could break.

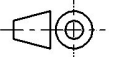
